1. Welcome, Introductions and Opening Prayer/Thought for the Day

Gordon Anderson welcomed all to the meeting and read a piece of relevant prose:

The Words of a Teacher - Clifford Jones (full text at the end of the minutes)

2. Election of Chairman

Upon the proposition of Councillor Mrs Hayes, seconded by Cllr Blatchford, **Gordon Anderson** was elected as Chairman of SACRE for the academic year 2011-12.

3. Appointment of Deputy Chairman

Upon the proposition of Gordon Anderson, seconded by Anne Gibbons, **Paula Ridgway** was appointed as deputy chairman.

4. Minutes of the Meeting held on 7 July 2011

The minutes of the meeting held on 7 July 2011 were approved as a correct record, subject to the following amendments:

Page 1: David Fawcett was a Church of England representative, this needed to be amended.

Minute 185: Gordon Anderson stated that he would continue as chairman for this academic year.

Minute 188: Circular 1/94

Minute 189: typo in third paragraph, should be 'at'.

Minute 192: Gordon Anderson also attended the Joint SACRE's Conference.

5. Matters Arising not Already on the Agenda

Minute 186: The Chairman advised that as there was a very full agenda for this meeting, Abby Thomas had not been asked to attend.

6. **SACRE Membership**

- a) Resignations and vacancies: The Chairman advised that there were currently four vacancies that needed to be filled as follows:
 - i) The Free Churches:
 - ii) Church of England, a nomination had been agreed and would be forwarded to the clerk.
 - iii) NAHT: the clerk agreed to write to the head office.
 - iv) ACSL: the clerk agreed to write to the Chairman, Kathy Winrow.
- b) Humanist request: The Chairman reminded the meeting that he had sought advice from the Borough Solicitor, copies of which had been circulated. There was no requirement to provide a formal slot in Group A, as humanism was not a faith. It was noted that SACRE had the power itself to co-opt a humanist if it felt that was appropriate and if there was a vacancy. No vacancy existed at the time of the meeting under the existing constitution.

It was unanimously agreed that the SACRE could not co-opt a humanist representative nor would recommend to BFC any change in SACRE's constitution.

7. Resources Centre and Artefacts Report/Update

Martin Surrell reported that two schools had borrowed artefacts during the period September 2011 to November 2011. The artefacts borrowed were for Sikhism and Hinduism.

8. The Monitoring of RE and Collective Worship in Bracknell Forest Schools - Report and Update

Martin Surrell reported that a briefing about the new Ofsted Framework for Inspection (due to come into effect in January 2012) had been given by HM Inspectors. There would be a consideration of the impact of collective worship on personal, social and moral education, if there were any concerns with this, collective worship would only then, be commented on.

Jo Fageant referred to Minute 188 from the last meeting and stated that the RE community was pressing the Government to drop the Circular 1/94, as it was not seen to be a sound document.

Martin Surrell reported that he would liaise with Bob Welch to finalise a report on the results of the survey completed by RE teachers in the Borough and submit it to the next meeting.

9. School RE Examination Results 2010 - Review

Martin Surrell provided SACRE members with provisional examination results for 2011 for the Borough and stressed that the results needed to be kept confidential at this stage, as they were still provisional.

Martin Surrell reported that Easthampstead Park School had entered all their pupils for the full course this year and had not participated in the short course. It was noted that Brakenhale had not entered either the full of the short course.

The Chairman and SACRE members expressed their satisfaction for the positive results.

10. Curriculum Review and EBacc Developments - Update

It was reported that it was now clear that R.E would not be included in the Ebacc. The Chairman reported that he had written to his MP on this matter. It was reported that there was a facebook group titled 'Keep RE as part of the Ebacc group', members were encouraged to support this group to continue the campaign.

11. **SACRE Annual Report**

Jo Fageant reported that the Annual Report would be submitted to the Secretary of State and to NASACRE. Whilst there was a legal obligation to produce these reports, there was no formal requirement to submit the report anywhere. In the past reports had been submitted to QCDA, which no longer exists.

It was acknowledged that the reports were very useful to local schools.

There was no formal deadline to finalise the report however Jo Fageant asked that members read through the report and submit any comments to the Chairman by the end of November. SACRE delegated authority for approval of the final report to the Chairman. A finalised report would be sent to all members.

It was noted that the report was not yet complete, a number of areas needed to be completed such as exam results and clarification about NASACRE subscription.

12. RE Trails in Bracknell Forest - Update

It was confirmed that whilst there were a number of places of interest in Bracknell, it would not be possible to create a trail for school children due to the large distances between the places of interest.

13. Any Other Business

It was agreed that SACRE had a clear mandate to monitor the provision of RE in the Borough and members agreed that whilst community cohesion could be viewed in

some instances to be based upon or influenced by faith, it was not considered to fall directly under the remit of SACRE.

Addendum

The Words of a Teacher - Clifford Jones

Though I speak with authority in the assembly hall and teach with skill in the classroom, though I lecture brilliantly on a wide variety of educational subjects, though I have appeared on a television panel of education and written a best selling textbook on the subject, if I have no love for my pupils it is not enough.

If I have a first-class honours degree, a diploma in education, or a distinction in education in my college course, if I am in close touch with the latest trends in education and heartily approve the newest ideas, if I have no love for my pupils it is still not enough.

Love makes the teacher very patient, very kind; a teacher who loves his pupils is never sarcastic, never rude never bears a grudge, is never unfair. A teacher's love never ends.

Teaching techniques will soon be out of date, for our present ideas on education are only partial and that which is only partial will vanish when all education is seen in its wholeness.

There are three things in education which endure - faith in the ultimate value of education, hope in the future of education, and the love of teachers for their pupils, and the greatest of these is the teacher's love.

MPs form group to protect teaching of religion

The future of religious education in • schools is under threat as a result of • government reforms, MPs claim.

A new all-party parliamentary • group is being set up to safeguard the • subject, amid fears it is being sidelined • after its omission from the list of • subjects recognised by the Government's new English baccalaureate.

The new body, which will be supported by all the country's leading religious groups, as well as the British Humanist Association, follows a poll by religious education teachers showing that 30 per cent of schools had cut the time for RE since details of the new baccalaureate had become known.

This is despite warm words by • David Cameron and - this week - the • Queen, about the central importance • of faith to today's society.

Speaking at a multi-faith reception • alongside the Archbishop of Canterbury, the Queen said that she believes • the concept of the established Church • is "commonly under-appreciated" and • "occasionally misunderstood".

Earlier this week Baroness Warsi, • the Conservative party chairwoman, • warned of the danger of "militant • secularists" downgrading the importance of religion in public life.

On the subject

Religious education is a statutory subject for all pupils to learn up to the age of 16.

However it has a unique place in the curriculum because what is to be taught is not laid down as part of the national curriculum.

In practice it is down to Standing Advisory Conferences on Religious Education (SACREs) in local areas to determine the nature of the curriculum locally. The content has changed markedly over the years so that pupils now study a wide range of comparative religions and their

She also derided the way in which • across Europe and in the United Kingdom, "spirituality is suppressed and • divinity downgraded".

RE has soared in popularity as a • subject at GCSE level since the 9/11 • terrorist attacks in New York.

The number of students studying it • has increased from 113,000 to 460,000 • in the past 15 years.

Stephen Lloyd, Liberal Democrat•MP for Eastbourne and Willingdon,•who will chair the new all-party parliamentary group, said: "It is clear that•pupils find it a rewarding and fulfilling•subject." RE is a statutory subject on•the syllabus for five to 16-year-olds, but•it is not included as part of the national curriculum.

Local RE bodies have been given the, •task of interpreting how it should be •taught in schools in their areas. Under •the new English baccalaureate, students will qualify for it if they achieve •five A* to C grade passes at GCSE in •English, maths, science, a foreign •language and a humanities subject,

However, the humanities are restricted to history and geography•with no mention of RE and art. The•Religious Education Council, which includes 50 different religions, will•provide professional support for the•new group.

origins (although Christianity must be given a high focus)

In addition, a survey of 80 SACREs by the British humanist associations revealed that 62 of them included mention of humanism in their curriculum.

A typical GCSE syllabus for a religious studies exam includes topics on God, death, human relationships, poverty, and wealth, prejudice and discrimination, religion science and the environment, sanctity of life and war and peace.
