# Supplementary Capital Approval: Libraries Director of Environment, Culture and Communities

## 1 Purpose of the report

1.1 To release s106 monies received by the Council for the provision of library services in order to support the introduction of new technology into the library service.

# 2. **RECOMMENDATION**

2.1 That £21,878 as detailed in Annexe 1 be approved to support the provision of enhanced technology within the borough's libraries.

## 3 REASONS FOR RECOMMENDATION

3.1 The library project to install self service and technology assisted opening is, based on estimates, predicted to overspend slightly and the use of s106 funds mitigates against this. It is also an opportunity to utilise S106B receipts which, in isolation, are difficult to spend as a capital sum given the generally small scale of receipt.

# 4 ALTERNATIVE OPTIONS CONSIDERED

4.1 There are no alternative projects for these funds.

## 5 BACKGROUND INFORMATION

- 5.1 Council has previously approved a total capital allocation of 689k, including £57k of s106 money, for the provision of self service and technology assisted opening in all of the borough's libraries and that project is progressing well.
- 5.2 Most of the libraries will have to have some building modifications to allow the public to access them when no member of staff is present (additional fire escapes for example) and while an initial estimate was made in the original project plan for such expenditure, the more detailed estimated costs of these modifications since project inception indicates that they *may* cause the project to be slightly overspent.
- 5.3 Annexe 1 is a list of all the s106 receipts for libraries excluding any relating to Harmanswater library. As can be seen, the majority are very small amounts and none could realistically support a capital project in isolation. Given the potential overspend, it is recommended that this money be released now to support the project. In the event that the predicted overspend does not materialise, the s106 monies would be used in the project as a priority resulting in a saving to the council. Importantly, it would also utilise s106 receipts which in isolation are difficult to spend on capital projects and if unspent would be in danger of being returned to the developer.
