██████████ Terrace Road North	<p>██████████ is objecting to the proposals to add a 15 metre length of single yellow line with a restriction from 1st Nov to 31st March 7pm to 12am as it is not only gritting lorries that get stuck but also fire engines, lorries, buses and horse boxes.</p> <p>██████████ states that the busiest times for parking are when the workers are visiting the local pub on their way home from work between 4pm and 8pm.</p>	<p>We are aware of the need to protect this area of highway for use by the Gritting vehicles which are the widest vehicles using this route on a regular basis. Evidence has shown that gritting lorries can get stuck in this specific location within Terrace Road North if parking is on both sides of the road, and as such, the proposed proposals are intended to alleviate this issue during gritting times.</p> <p>We have discussed the issue of gritting lorries getting stuck with the Highway's Maintenance team responsible for the winter maintenance programme and agreed that this part of the route will be serviced first when weather conditions dictate it is necessary. We have been informed that the most common time for the gritting operation is early evening hence the proposal for the restrictions to commence at 7pm.</p> <p>We are also aware that a balance needs to be struck between restricting parking on the public highway to facilitate this movement, and maintaining as much on street parking as possible in this area for local resident and community facilities. We have therefore consulted with local bus companies, emergency services and properties within the vicinity of the proposal to invite comment. The bus company have informed us that they are not experiencing any issues in Terrace Road North that they feel require action and we have not received</p>	Proceed as advertised
