REVIEW OF STATEMENT OF GAMBLING PRINCIPLES Chief Officer: Environment and Public Protection

1 PURPOSE OF REPORT

1.1 The purpose of this report is to advise the Committee on the results of the consultation on the review of the Council's Statement of Gambling Principles, and to seek recommendation to the Executive that the Council adopts the revised Statement of Gambling Principles with effect from 31 January 2013.

2 RECOMMENDATION

2.1 That the Committee notes the results of the consultation and recommends to the Council that they adopt the revised Statement of Gambling Principles at Annex B with effect from 30 January 2013.

3 REASONS FOR RECOMMENDATION(S)

3.1 Under the Gambling Act 2005, the Council is required to review and consult upon its Statement of Gambling Principles ('the Statement') every three years from the date of adoption. The present Statement of Gambling Principles was published on 31 January 2010 and therefore must be re-published on or before 31 January 2013.

4 ALTERNATIVE OPTIONS CONSIDERED

4.1 There are no alternative options as the consultation and revision of the Statement are legal requirements.

5 SUPPORTING INFORMATION

- 5.1 Section 349 of the Gambling Act 2005 requires all licensing authorities to prepare and publish a statement of the principles that they propose to apply in exercising their functions under the Act. The Statement will last for a maximum of three years and can be reviewed and revised by the authority at any time. - 5.2 Consultation took place from March to May 2012 with a range of organisations including current licence holders, trade associations and community groups. The consultation was also publicised on the Council's website. Three responses were received to the consultation and a summary of the responses can be found at Annex A.
- 5.3 The revised draft Statement of Gambling Principles is attached at Appendix B.
