# 1 Introduction

**1.1** The purpose of this Consultation Statement is to set out the consultation process on the Statement of Community Involvement (SCI). The SCI sets out who, how and when the Council will engage in the preparation and formulation of planning policies, and the determination of planning applications.

**1.2** This document contains the following information:

- The consultation process that was undertaken (see Section 2 'Consultation Process'), and
- Summarises the key issues raised in response to the consultation, and respond to the issues that were raised (see Section 3 'Summary of Responses to Consultation').

## 2 Consultation Process

**2.1** Consultation on the revised SCI took place between Monday 9th September and Monday 21st October 2013, following a resolution by Executive on 9th July 2013 to agree the revised SCI for consultation. **2.2** Consultation on the SCI comprised the following elements:

- Update on the front page of the Council's web site, and the Environment and Planning home page to include notification that the SCI Consultation had commenced (See: Appendix 1: 'Screen shots of web pages').
- Press release to local newspapers/radio stations at start of consultation, including 'news' item on Council's web page. (See <http://www.bracknell-forest.gov.uk/howdoyouwanttobeinvolvedinplanning>).
- Notification to Parish/Town Councils and provision of hard copy of consultation document/response forms. (See: Appendix 2: 'Consultation Letter to Parishes').

## **3 Summary of Responses to Consultation**

# 'Old Bracknell was thriving'

THE regeneration of Bracknell has been a long time coming and is the second time the town has been rebuilt. From a market town to a 1950s' New Town and now a ghost town, three people share their memories of Bracknell through the years.

FORMER Bracknell town mayor and councillor of 10 years ADRIENNE JONES has lived in Bullbrook since she was born in 1938.



Her great, great grandfather, who was a master chimney sweep, arrived in Bracknell in the 1850s.

WHEN the New Town Bill was passed in 1947, I was nine-years-old and living with my mother, father, sister and two brothers in New Road, Bullbrook, where an office block now stands.

When I was born, Bracknell was two suburbs – Old Bracknell and Priestwood – the common ground being the High Street.

Some people think Bracknell didn't exist before the new town and that really annoys me. It was a thriving market town.

I remember the market at the top of the High Street before it moved underneath 1960s' Winchester House.

One of my childhood memories is that every now and again a pig

would escape from the market and go down High Street followed by a man bellowing. I suggested to Helen Barnett [Bracknell Regeneration Partnership] that pigs be included as street decoration in the regenerated town because of this memory.

I remember when the old houses were knocked down and replaced with the 1950s' structures, some of which are now being demolished.

I think the first house was ready one Christmas Eve in the 1950s. I remember there being 200 terraced houses on the right-hand side of Stoney Road – they looked great at the time.

One of my memories of the new town in the 1950s – when there were houses in Priestwood – was seeing this tide of prams and pregnant women coming up the street.

It was quite interesting for quite a

long time. You could tell the new town from the old town because the new town had sodium lighting and Old Bracknell still had gas.

With the regeneration it will be interesting to see what they put up. I think the original redevelopment was going to be in the early 1980s.

They can't keep Bracknell looking totally dead. I will reserve judgement until it is finished but I just wish they would get on with it!

## Positive news after all these years

GETBRACKNELL website editor HUGH FORT looks back nine years of covering the long-awaited regeneration story for the *Bracknell Forest Standard*.



"ITLL never, ever happen". At the time, as a naive young hack, I couldn't understand why people were so negative about the plans for the regeneration of Bracknell.

It sounded amazing – a £750 million plan from Bracknell Regeneration Partnership (BRP) to knock down the crumbling old town centre and replace it with a super-modern shopping experience.

But upon speaking to people, clearly there had been years and years of talk and not much action, leading to a strong feeling of scepticism about the whole project.

I'll always remember the plan for the old plan for the town centre, a huge, futuristic drawing that looked more like a space station than a town centre.

Despite the impressive designs receiving outline planning permission, those plans never materialised.

In 2006, outline plans did appear and it is these plans that have led to the work that began this week.

Council leader Paul Bettison said the new plans would be "phase-led", planning talk for "done in parts".

Looking back – hindsight is a wonderful thing – this proved sensible as the recession hit and hit hard the next year.

I'm no expert on these things, but you do wonder if Bracknell had pushed ahead and then been hit by the recession what on earth would have happened. Bracknell could have ended up with half a town as a ghost town full of shiny new shops with no bodies in them. Then in 2011, all of a sudden, there was movement. Things moved very swiftly after Waitrose confirmed, a refreshing change from years of uncertainty. And that leads us up to this point. Lo-and behold, the work has actually begun.

There are still concerns about the retail mix, whether people will choose Bracknell over centres like Reading, what will happen to Bracknell Market and whether Winchester House will loom over the new town like a big, ugly reminder of the bad old days of architecture.

I can't answer those questions, but after nine years of endless meetings, relentless negativity and general uncertainty we are FINALLY seeing progress.

On a personal note, having spent many hours standing in sub-zero temperatures trying to do vox pops, please can the new centre not be a wind tunnel?
