ANNEXE A

RESPONSIBILITY FOR EXECUTIVE FUNCTIONS

Unless the Constitution or the law requires otherwise, the Executive is responsible for the formulation of the budget and policy framework and the implementation of these in respect of all functions and services other than those listed in paragraphs 1 and 2. Under the terms of the Executive Procedure Rules, the Executive Leader may further delegate onwards to individual members of the Executive, a Committee or Sub-Committee of the Executive, or joint arrangements.

Such onward delegations are reported to the Council and recorded in this part of the Constitution but shall not in any event prejudice the management and operational delegations to officers approved by the Council and set out in Appendix 1 to this part of the Constitution. Individual members of the Executive shall observe any limits on delegations which may be specified by the Council and shall, at all times, act in compliance with the Council's Financial, Contracts and all other relevant procedure rules as set out in this Constitution.

A. INDIVIDUAL MEMBERS OF THE EXECUTIVE

In accordance with Section 15(4) of the Local Government Act 2000 Members of the Executive are allocated responsibility for the following functions:

Executive Member for Council Strategy (Leader of the Council)

The **Executive Member for Council Strategy** is responsible for the following functions, to the extent that they comprise Executive functions:

- 1. The formulation and implementation of the Community Plan.
- 2. Making arrangements for the formulation of proposals for the annual Revenue and Capital Budgets and of proposals for the level of Council Tax.
- 3. Financial (including Investment and Insurance) Management.
- 4. The powers and duties of the Council for the collection of local taxes.
- 5. The internal and external audit arrangements for the Council.
- 6. The co-ordination of annual service planning, review and performance monitoring.
- 7. The Council arrangements for community engagement.
- 8. Matters relating to the Local Government Association and Regional Groupings.
- 9. The management, maintenance, improvement, development and re-development of Bracknell Town Centre, in so far as these functions are not the responsibility of the Bracknell Town Centre Regeneration Committee
- 10. The appointment of Members to Committees of the Executive, including, where the Executive Member for Council Strategy considers it appropriate, the appointment of the Chairman and the Vice-Chairman of those Committees.
- 11. The determination of the terms of reference of the Committees of the Executive.
- 12. The appointment of Members to external bodies, whose functions are the sole responsibility of Bracknell Forest's Executive.
- 13. To act as Chairman of meetings of the Executive.

Executive Member for Leisure and Corporate Services & Resource

The **Executive Member for Leisure and Corporate Services and Resources** is responsible for the following functions, to the extent that they comprise Executive functions:

- 1. Overall performance and effective operation of the Corporate Services and Resources Department (Democratic and Support Services, Financial Services, Information and Communications Technology, Legal Services, Human Resources, BF Services, Customer Services and Corporate Property).
- 2. The development and introduction of Information and Communications Technology and its use.
- 3. The Council's powers under Sections 29 and 38 of the Local Government (Miscellaneous Provisions) Act 1976.
- 4. The Council's powers under Section 2 of the Local Government Act 2000 [the promotion of well-being.]
- 5. Building Maintenance Services.
- 6. The management of all property and land owned by the Council other than that which is used as operational property for functions which are allocated to another Executive Member.
- 7. Strategic and planned maintenance of all Council properties other than schools and the Council's housing stock.
- 8. The provision of, maintenance and management of the Council's central fleet of vehicles and mechanical equipment and plant.
- 9. The provision, maintenance and development of leisure services and facilities.
- 10. Voluntary managed Community Centres
- 11. Overall performance of the Environment and Leisure Department relating to those parts for which the Executive Member is responsible.
- 12. Management and promotion of rights of way and recreational routes for the Borough.

- (ii) to carry out particular tasks and projects as agreed with the Executive Member from time to time;
- to attend public and private meetings of the Executive as an observer and in the absence of the Executive Member to propose motions and speak (but not to vote);
- (iv) in the absence of the Executive Member, to speak at meetings of the Council on matters relating to the allocated portfolio area.

Executive Support Members may serve on Scrutiny Panels and Working Groups provided that they must withdraw from any discussion on matters within the portfolio area in which they act as Executive Support Member. It would, therefore, be inappropriate for Executive Support Members to act as Chairman or Vice-Chairman of a Scrutiny Panel.

Executive Support Members shall not be appointed to the role of Chairman or Vice-Chairman of the Licensing & Safety Committee or the Planning & Highways Committee.
