Substantial food and dining facilities shall be available at all times throughout the premises.

Mobile bars and temporary structures may be used within the grounds of the premises for the purposes of providing licensable activity authorised by this licence.

Table service shall be available throughout the premises.

Supply of alcohol 24 hours may be permitted in all guest bedrooms.

The premises shall install and maintain a comprehensive CCTV system. All recordings shall be stored for a minimum period of 31 days with date and time stamping.

c) Public safety

Health and safety risk assessments shall be undertaken and staff trained therein
