Table service shall be available throughout the premises.  Supply of alcohol 24 hours may be permitted in all guest bedrooms.

The premises shall install and maintain a comprehensive CCTV system. All recordings shall be stored for a minimum period of 31 days with date and time stamping.
c) Public safety
Health and safety risk assessments shall be undertaken and staff trained therein
