Hello,

I am writing to you as I have heard that the AandA Plus kebab van on Bull Lane are being threatened with an investigation that may result in having their licence revoked. I understand this is on the basis on 1 complaint. I find it quite shocking that there should even be a formal investigation for one complaint when someone from the council could easily visit the site to check the facts, a much more cost effective option surely?

I have been using this kebab van for a few months now - I find them quiet, the noise level is low and if there is a queue, people are just quietly waiting in line. This is very different from the one I used to use on Market Street who catch the rowdy pub trade around closing time - I have changed to AandA Plus as I have felt quite intimidated on occasions as a lone female standing at the van in market street, and AandA are in a much safer location. AandA Plus do not operate past 11 o'clock in the evening, which seems awfully early to me and caught me out at first when I went along assuming they would be open past this time.

I do hope that sense prevails - I believe they have been there for some time and now are threatened with their livelihood due to the opinion of one resident. Even if there were noise, surely the noise abatement rules only kick in at 11pm after they have closed? I cannot see any justification for the complaint about noise - it is not something I or my husband have experienced at any time, and we are now regular customers. Perhaps these residents expect free or discounted kebabs and are complaining as they don't get them!!!!
