This option is not recommended in the current budget circumstances as increasing current rates could generate additional income of at least £50,000 if the current estimates for car park usage are realised. Additionally, due to the Coronavirus pandemic, the service is forecast to under recover on income against target by around £2,000,000 according to the current worst-case scenario estimate. The increases proposed would help bridge some of this gap.
