Document Title	Pre - Submission Bracknell Forest Local Plan (BFLP)
Nature of plan being prepared	The BFLP provides a framework to guide the location and level of development in the Borough between 2020/21 – 2036/37. It is divided into two parts: Strategic Matters (Part 1) and Non Strategic Matters (Part 2).
	Part 1 includes a vision, objectives, and strategy for the level and distribution of development, including housing and economic development. Overarching policies are also included on the provision of new infrastructure and issues relating to climate change including design.
	Part 2 deals with the more detailed development management policies that are used to assess planning applications.
Purpose of consultation	The purpose of the consultation is to seek views on legal compliance and the 'soundness' of the BFLP in preparation for submission of the Local Plan to the Secretary of State for Examination. This is a statutory consultation under Regulation 19 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended).
	It is also necessary to consult on the Sustainability Appraisal and the Habitats Regulations Assessment (covered by separate legislation).

Who should be consulted	As prescribed in the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended) and specific legislation covering the SA and HRA.  • Those living and working within the Borough; • Landowners and consultants; • Parish/Town Councils within the Borough; • Neighbouring County, District and Borough Councils; • Specific consultees (such as 'duty to co-operate' bodies and specific consultees, including Environment Agency, Natural England, Highways Agency and Historic England); • General consultees (including voluntary bodies, bodies which represent the interests of different groups).
Why we are consulting them	There is a statutory requirement to consult on legal compliance and the 'soundness' at this stage of the plan making process.  Those living, working and owning businesses within the Borough have the potential to be directly affected by future planning policies and development proposals, so should have an input in terms of planning for the future of the Borough.  Certain strategic matters will have an impact on areas beyond the Borough boundary (such as meeting housing needs, Thames Basin Heaths Special Protection Area, and transport matters) which require liaison with specific bodies, such as neighbouring Authorities, Environment Agency, Natural England, Highways England and Historic England.
How we will be consulting	Regard needs to be given to the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended) and the Council's Statement of Community Involvement (February 2014) as revised by the temporary update to cover the impact of Covid 19.  The Council will use a range of communication methods in order to ensure inclusive consultation on the BFLP having regard to public health guidelines on social distancing during the consultation. This may mean that it will not be possible to deposit physical copies of the main documents at specific venues including the Council Offices at Time Square, parish council offices and local libraries.
