Our response - There is one other disabled parking bay on the entrance to the parking area from the main Holbeck access road.

The proposed bay will be marked on the carriageway and cars do park in this position at present. Whilst it is accepted that the disabled bay will be restricted to blue badge holders, the applicant currently parks in the parking area so in reality there is no overall change in the spaces available for the residents already parking there.

The applicant has a car which is a pre-requisite for the provision of a disabled parking bay to be considered.

These cars cause obstructions and can led to dangerous situations where dropped kerbs are blocked and near collisions at the junction of Stoney Road & Honey Hill Road. X XXXXXXX adds that removing some of the parking spaces and restricting it to disabled only will only exacerbate this issue. X states that X is unaware of any need for disabled parking as none of the nearby residents have need of it. X XXXXXXXX states that X XXXXXXXXXXX needs close access to their home as X sometimes struggles to walk but is not registered disabled. X also has a XXXXX XXXXX and being able to park close to his home makes it easier & safer to get them in/out of the car. X suggests disabled spaces could be made available on Stoney Road and not directly outside peoples homes. Alternatively, parking permits could also be put in place to stop non Honey Hill Road residents parking in the road.	Whilst the bay will be for the use of anyone with a blue disabled badge, this particular bay has been applied for by a local resident. The Council confirms that the applicant has met the criteria for the provision of a disabled parking bay, lives near to where the bay is proposed and this location was agreed with them. Applicants must prove that they have reduced mobility which is backed up by a written statement by a medical professional. The proposal is to place one disabled parking space outside a property comprising of four flats (9A, 9B, 11A & 11B). There is no proposal to place a disabled parking bay within the vicinity of no XX Honeyhill Road which is approximately 40 metres away. The proposal will not affect X XXXXXXXX's ability to park outside X property. Residential disabled parking spaces are provided as close to the applicants property as possible whilst ensuring their positioning is not to the detriment of other road users.	Proceed as advertised

X X XXXXXXXXX Prescott	The resident does not oppose the proposed disabled parking space in Prescott but states that parking is already ridiculous without taking away another space. The resident states that there is a disused SSE brick building that could be knocked down to provide extra parking. X adds that the grass verges have builders vehicles parked on them continually. X asks if the verges could be turned into parking areas or fenced off to stop the parking. X asks why the signs that are in the road concerning parking are not enforced.	Given the proximity of adjacent trees there is not enough available verge space to construct additional parking bays and it is likely that any such proposals would be refused planning permission due to the negative impact on the character of the road. It is assumed that the signs the resident refers to were erected by Berkshire County Council who were the Highway Authority at that time to enable them to enforce the part of the 'Berkshire Act 1986' which prohibits long term parking and no parking over the verges. Unfortunately, the Bracknell Council's Civil Enforcement Team cannot enforce the Berkshire Act as the authority to enforce it was not transferred to us when we became a unitary authority in 1998. As a rule, we tend to leave these signs up to act as a deterrent to some drivers from parking long term and on the verges, even though it is no longer an enforceable offence. Unfortunately parking on grass is a widespread problem in various areas throughout the borough and the Council no longer has the resources or funds to address this problem unless there is major ongoing parking causing significant damage to grass and particularly to trees in an area. The Council's position on verge parking is that although it is not encouraged due to the damage that it causes, repairs to grassed areas and verges will only be carried out if they are very badly damaged with deep ruts and likely to cause a hazard to pedestrians. At this time the Council can take no action other than placing stickers on cars that are parked when we are in an area cutting the grass.	Proceed as advertised
