

In Bracknell Forest Council Motion (02/2019), passed at Full Council on 17 July 2019, the council committed to becoming a net-zero greenhouse gas emitting borough by 2050.


The motion states:

*“This Council strongly believes in the need to continue its work to address the impact of man-made Climate Change on our local communities. To this end, this Council asks the Executive to **develop detailed action plans with measurable ambitious annual targets** and an annual report to address this pressing matter to ensure that the Council meets the government target of eradicating its net contribution to climate change by 2050”*


Headline Metrics from 2021



BFC's total CO2e emissions from the council's transport fleet, plus gas, electric and water consumption was 5,028 tonnes. This compares to the initial figure of 6,178 in 2019 and 5,326 from 2020.

Business, Energy and Industrial Strategy department data (BEIS) up to 2019. BFC data was 426.1kT CO₂e which is down by 18.2kT from 444.3 in 2018 and compares to our initial benchmark of 728.5kT in 2005, representing a 41.5% reduction overall.

Strategic highlights from 21/22

Corporate decision making has been changed to incorporate and ensure that carbon emissions are now part of the matrix of Financial Resources, Legal authority, Equalities impact (public authorities equality duty), **climate change impacts** and **health in all policies**

Service plans 2022/23: In the annual review and updating of the Council Plan, the climate change elements have been identified and flagged to ensure that these can be monitored and tracked via the Council Plan Overview Report (CPOR) process

Public Health: The Public Health team have completed an exercise of funding bids. A number of PH funded climate change programmes are being looked at including the Eco Rewards Behaviour Change Incentive Scheme, Get Green and Active, Air Quality in the borough and reducing the impacts of poor housing

Strategic highlights

Business Survey 2021 - Whilst **51%** of businesses have the intention of being more environmentally friendly, just **12%** have a specific target or aim to achieve net-zero and just **5%** cent have set a deadline to this commitment

External / Government funding: Cllr Hayes led a Ministerial visit (25 Feb 22) to the closed land fill site, London Road. **Guy Oppenheimer MP, Minister for Pensions and Financial Inclusion** and local MPs **Adam Afriyie** and **James Sunderland** attended the site to discuss a range of possible projects, including a charging hub, solar array and storage batteries. The council is exploring how to use brownfield sites, like this one, for green initiatives.

Grant funding

Heating decarbonisation project: The project associated with the **Salix – GOL - LCSF2** award of **£154k** of funding for heat decarbonisation plans for all of the Councils property stock including schools not already funded are progressing in line with scheme schedule

Active travel initiatives: Highways and Transport service has received a Department of Transport grant of **£160k for active travel initiatives**. The funds are being used to expand cycling routes to Crowthorne and Sandhurst and have allowed the commissioning of promotional videos, interactive maps, cycle led rides, family events, and working with businesses and schools to increase participation.

EV charging points: The council has secured **£100k** funding to roll out 32 residential electric vehicle charging points across the borough. These will be low wattage / slow chargers, aimed at overnight charging.


Air quality: The Public Protection Partnership has secured **£259k** of DEFRA funding to help implement measures to reduce the impact of poor quality air on people's health. Air quality equipment will monitor levels around 14 specific schools locations.

Public Protection Partnership – air quality

The PPP ran an **anti-idling** car bumper sticker design competition for primary schools. School children across the three local authorities were asked to create a design for a car sticker which would encourage the driver behind them to switch off their engines when appropriate to do so, saving emissions from idling. From a grand total of 348 entries, the winning impactful design was submitted by a year 6 pupil from Ascot Heath Primary School.





A project to start education around engine idling and idling enforcement will be a focus for the service over the coming year. This programme will initially target taxi ranks, schools and known hot spot areas around the borough.

Green Homes Grant Funding

£900k spent / further £1M planned); In terms of the home decarbonisation projects via the government's Green Homes Grants Local Authority Delivery schemes (GHG LAD), the council completed the works from GHG LAD 1 (£900k grant received) back in the Summer of 2021.

The Council have further funding from both GHG LAD 2 (£87k for spend by 30th June 2022) and GHG LAD 3 – also referred to as **Sustainable Warmth and Home Upgrade Grants** (£1M for spend by 31st March 2023).



Car Park chargepoints

At the time of writing, there are 35 public use chargepoints in Bracknell Forest, located within either Council or privately owned car parks. Their types and locations are summarised in Table 2 and 3 below.

Parks & Countryside

The service have recently finished a busy **tree planting** period incorporating **2,795** trees over 20 sites as part of highways improvements and improvements to public green spaces.

The total area of **Habitats of Principal Importance (HPI)** has increased by **50.97** hectares mainly due to new mapping of ponds across the borough. 700 ponds were identified which support biodiversity, store water, reduce flooding and act as carbon sinks.

The total area of **Local Wildlife Sites (LWS)** has also been increased by **17.7** hectares with the re-designation of Lily Hill Park. In the climate change context, Lily Hill Park has woodland and meadows that provide urban cooling, carbon storage and support the survival of biodiversity.

A project to finalise the installation of a **ground source heating pump** at Westmoreland Park Pavilion is ongoing and the service are also looking at **increasing rainwater harvesting** at a number of sites following successful trials at the Look Out and Westmoreland Park.

Highways and Transport

Funding has been secured to work on a **bus service improvement plan (BSIP)**. The BSIP sets out the combined vision for improving bus services in the borough. The Partnership with local bus operators is now working to publish an Enhanced Partnership Plan and Scheme which will set out actions to help deliver the BSIP aims.

Partnership work with the **Eco Rewards scheme** has continued to incentivize local schools and residents to choose sustainable travel options. At the end of quarter 3 there are now 9 schools participating in the scheme, and 45,000 green miles were reported during the quarter, increasing the overall total to 245,000 since launch.

Moving forwards the service will be undertaking a wide spread **consultation on walking and cycling habits** within the borough during Q4 to better inform planning on improving infrastructure and supporting a greater transition to these sustainable modes.


Environmental Services – Greening our Waste Strategy

- Performance on the council's food waste recycling service has been very strong throughout the first year. The year ended with over **6,000 tonnes** of food waste diverted from landfill.
- The average overall recycling rate is higher than targeted at **56%** for the year. This is a 13% improvement on last year which is very significant. Participation in the food waste scheme has also been sustained at an exceptionally high **90%** of eligible households. This compares to an average of around 60%-70% in other schemes.
- Efforts to reduce the total amount of waste ending up as landfill have also been successful representing **7%** of all waste currently – below our annual target of 10%.
- The diversion of food waste has produced a carbon saving of over **3.72 million kg of Co2e** in the first year.
- The service has also started collecting and analysing **waste fleet vehicle emissions**. A metric will be available at the end of the financial year and will serve as a benchmark for future measurements.





This is a huge achievement and we'd like to say a huge thank you to you for all your hard work, particularly over the past year. 🌞



Cllr Mrs Dorothy Hayes MBE, Executive Member for Environment and local recycling champion, has said:

"We are thrilled to have been shortlisted as the ninth least wasteful town in the UK. Our residents deserve a huge well done, as this achievement has really been earned by them. Over 5,000 tonnes of food waste has been saved from being sent to landfill in just 10 months."

By introducing weekly food waste collections, we have been able to reduce general waste collections and have seen a significant decrease in the amount of general waste being generated and collected. That combined with the new rule at our bottle banks which eradicates the need for separating glass bottles by colour due to new colour sorting technology, recycling has never been easier.

This really shows the compassion and respect our residents have for the borough and its environment, and we urge them to keep up the good work!

Key Projects moving forward

The plans for the redesigned **Commercial Centre** will incorporate some significant energy saving / greening elements. These will include a green roof providing thermal insulations and allowing the installation of solar PV panels; the heating via an air source heat pump; plus, the addition of electric vehicle charge points.

The council has secured £100k funding to roll out **32 residential charging points** across the borough. These will be low wattage / fast chargers, aimed at overnight charging.

Public Health funding will support several projects such as an **Eco Rewards** behaviour change incentive scheme; a scheme to promote '**Get Green and Active**' volunteering, and efforts to improve the health of some of our poorest residents through **home improvement works**

Our food waste collection scheme will start to expand to a further **20% of flats** (up to 1,800 residences) in the Borough.
