In what capacity are you completing this form?



Do you support the proposal to unite the school community on to one site by migrating the All Saints site to the Woodhurst site?





I know that my own family's physical health has been improved by walking to school and the social wellbeing of both myself and my child is hugely affected by our walks. Everything from small social interactions with elderly passers by, arranging playdates with other parents we meet along the way, passing comments and messages onto teaching staff right up to talking

				through serious issues with my child such as bullying and healthy eating will all be lost by forcing us to drive it will prevent us from talking about these issues as driving a car requires an extra level of concentration that walking does not which means my attention will - rightly - be on the road and not on my child. These sorts of interactions have a positive impact upon the whole community, my own family, families of other pupils as well as otherwise isolated, lonely and elderly members of the community that regularly have a smile put on their face by my child simply saying hello to them. A healthier population - physically and mentally - means reduced stress on local GPs/NHS resources. The council would do well to factor in predicted increases in cost on these services against any perceived cost savings gained in closing the All Saints site. The Woodhurst site was built on the presumption that most of the pupils attending would come from the surrounding housing developments enabling all but a few to walk. It was never designed to have such a large proportion of its pupil body arriving at school by car. This is clearly shown in

			the lack of existing parking and drop off facilities that were provided for the school in the original design. Forcing families to drive instead of walk will place additional financial burden on families who will now have to service, tax and fuel their cars at a time when the cost of living is already high and for some becoming unmanageable. Sopwith Road is currently a clearway preventing parents from stopping to drop off so a well designed traffic management solution will be imperative to the success of any unification. The current proposal offers an entirely inadequate traffic management solution for young children, those in years R - 2. What sort of traffic management will be put into place for the parents of younger children? Presuming that the kiss and drop is expanded to younger children it means that we will not be able to speak to other parents or the teaching staff. Playdates will become harder to organise having further impact upon my child's social wellbeing. Even small Education related issues/questions that would normally be dealt with in person will instead have to be addressed by telephone or email adding to the teaching staff's

				workload. The proposal cites that one of its goals is "Further cohesion of staff and children and parents, enabling a stronger school ethos" but I can not see how this will be achieved. If anything it appears that the polar opposite will be achieved. The school community will become less cohesive because we will all see and more importantly - speak - to each other a lot less often than we currently do as we will all sit in our cars a lot more. The proposal suggests that green incentives may be offered to ease the impact on the environment but the cost of any such scheme needs serious consideration. Will the cost of a green scheme really be cost effective and also able to offset the additional exhaust emissions from the increase in families driving? This increase of exhaust emissions will also have an impact on the respiratory health of the families that do choose to walk. There have been medical studies conducted which prove children are disproportionately affected by air pollution caused by exhaust emissions due to their lung development and relative proximity to the exhaust fumes. Such effects and fears may force some parents who currently walk

				to also drive further exacerbating the issue. It is also worth noting that there are a number of allotments along Sopwith Road. Has any consideration been given to the respiratory health of the plot owners working on those allotments as well as the health of the fruit and vegetables plants grown there given that there is likely to be a dramatic increase to the number of car exhaust emissions passing by every day? I question what thought has been put into converting the All Saints site into a Free School or an Academy? The information provided by the school governors explicitly states that there are only 2 options, remain as-is or unify; but other options simply must exist. The council's own documentation even suggests leasing surplus space to tenants and/or finding compatible users to share the space. I can imagine that an existing nursery or sporting service provider could very well be interested in leasing the surplus space to open a new site. What effort has been put into finding a tenant like this? Additionally, the provided information simply states that after a decision to unify has been made "there is no option to unmerge" but no matter the bureaucracy

My child joined Reception at All Saints in September 2020, it angers me greatly that we were not told during the application process that unification of the two sites was a possibility. In part I now feel that I was duped / tricked. If we knew then what we know now it is highly unlikely that Warfield C of E would have been our first choice school. Now we feel stuck sending our child to a large school with multiple forms. If I had wanted to send my child to a multiple form entry school then I would have applied to one last year. One of the reasons that we applied to Warfield C of E is because no matter which site we were assigned to there was only going to be a single form. When referring to the school ethos and values the governor's includes the phrase "extend to Woodhurst", add to that that the Woodhurst site is actually in Binfield (according to the council's ward maps) this shows that the All Saints site is surely the heart of Warfield C of E in both geography and mindshare. 				discussion to take place with greater spontaneity." but with the wide availability of collaborative technological tools that existed prior to the COVID-19 pandemic as well as all the new tools that have come to the fore since then should eclipse this aim entirely. In the vast number of situations team planning and discussion can be achieved entirely via these tools and often enacted with greater collaboration than ever before. We make use of a childminder to provide regular afternoon care for our child, a number of other parents at All Saints use this same childminder. I imagine there are also a number of other childminders in the area that are in use by All Saints pupils. These childminding businesses will be forced to take on additional costs or to withdraw care from the children who currently attend All Saints. Neither of these situations are ideal for either pupils, parents or the childminding businesses. An increase of fees will add to financial burden on families and a loss of children on role will place an unfair burden on the childminder and

The whole thing has felt like a pretence right from the start, I fear that the ultimate decision to unite the two sites was made long ago and these consultations are just the bureaucracy to make it appear otherwise. Some of the information provided in the original consultation seems to have been completely contradicted in the latest one, such as the impact this decision will have on school staff and their development. In doing this I feel like the first consultation was based on misinformation and therefore undertaken in bad faith. By establishing this pattern of

				site, which is going to be appalling especially when you consider the environmental impact of even just one person driving to the school. There are many news articles circulating recently with regards to children being exposed to harmful levels of air pollution during their school day. I am sure most of us are aware of the severe and lasting health problems that toxic air pollution can cause, including asthma and wheezing but it has even been linked to mental health issues and childhood obesity. We currently walk to school every single day. It is a 0.3 mile journey and takes us 7 minutes. The Woodhurst site is 1.3 miles away, an increase of a mile. It is not much for an adult, but for my own young children this is a walk that would tire them out before they reached the school gates. It would take us around 36 minutes to walk to the other site. The council used statistics to plan for the new 60-Form school to open, and this proved to be an immensely incorrect prediction as now a school site is to close to make amends for an error.
