X X XXXXXX	<p>X XXXXXX states that the area is used by hundreds of Deliveroo & Uber Eats drivers for picking up deliveries from restaurants in the town centre. Installing these restrictions will affect thousands of customers across Bracknell, Binfield, Wokingham and Ascot who use these apps.</p> <p>X asks that the parking restrictions are left alone or put back to what they were so they can all do their jobs.</p>	<p>The proposed restrictions are in response to the large increase in observed delivery vehicles being parked in this area. Whilst the Council has sympathy with X XXXXXX and other delivery drivers, the current double yellow restrictions are being, particularly in the evening, almost constantly ignored by delivery drivers albeit parking legally as loading/unloading is allowed under the current restrictions. However, the current restrictions are designed to protect the access to Service Yard H and Eagle Lane and this is being impacted by the number of vehicles parking in the area.</p> <p>Short term parking will still be available for delivery drivers in Service Yard H and the dedicated Loading Bay in the access area. Alternatively season tickets are available for the nearby High Street car park from the councils parking team.</p>	Proceed as advertised

Local Member Comments on Consultation responses:

Cllr D Hamilton - Yes I have seen the shambles that this area has become with traffic and parking. It is correct about the amount of traffic movements. Bearing in mind that there are pedestrians trying to cross road here I have seen how hard it has become as well as dangerous. Bikes and vehicles all left moving in and out quite quickly and sometimes erratically. The area was not originally designed for this and I support the change in signage. However, I have seen delivery motorbikes at different locations then decide to travel on the path to get to collections points at other locations. I would like to know what steps would be taken to stop this happening if it became a problem with pavement collection as a result?

I am concerned though to some extent that the problem needs a regulated area as I am not sure it will simply just stop and I do understand the need for local business to offer this service. Is this being considered Please confirm

Council response - Stopping motorbikes riding on the footway is a very difficult issue to physically prevent. Bollards on the footway need to be spaced so to allow wheelchair/double pushchair access by law which also allows motorbikes to pass between them. Railings placed on the edge of the footway will need to leave gaps at pedestrian crossing points so motorbikes would be able to gain access at these points also. Clearly riding a motorbike along a footway is illegal so the only feasible way to prevent this is to liaise with the Police with a view to them carrying out enforcement action.

We are aware that this issue is not confined to this location and it is being looked at by the Town Centre Management Team. We understand they are talking to the local businesses as to what solutions may be available and how the deliveries could be better regulated.
