 - (e) The release of £1.5m from s106 monies to fund capital projects outlined in paragraph 5.7.

- A general contingency of £1.000m be included, use of which is to be authorised by the Chief Executive in consultation with the Borough Treasurer in accordance with the delegations included in the Council's constitution (section 9.5 of the report);

The total expenditure before allowance for loss of interest from any use of balances of £76.248m, as shown in Table 6 (section 10) be approved;

- A contribution of £1.590m from revenue balances to support revenue expenditure be agreed;
